General

Winch Trading takes the protection of your data seriously and takes appropriate measures to prevent misuse, loss, unauthorized access, unwanted disclosure and unauthorized modification. Third Parties

Winch Trading will handle your personal details with care and will only pass them on to third parties if this is necessary or if Winch Trading is obliged to do so on the grounds of the law. Winch Trading is not responsible or liable for the way in which third parties handle your personal data.

Processing of personal data

Winch Trading only processes your personal data in order to come into contact with you, to make the agreement and to offer, deliver and invoice our services.

Storage period

Winch Trading will not keep your personal data longer than strictly necessary for the purposes for which it is processed, unless this is necessary to comply with the legal obligations.

Automated decision-making

Winch Trading does not take decisions based on automated processing on matters that can have (significant) consequences for persons. These are decisions that are taken by computer programs or systems, without involving a person.

Amendments

Winch Trading reserves the right to change the Privacy Statement at any time. These changes will be announced via the website of Winch Trading. The latest version can be found on our website. Winch Trading regularly advises you on the web page to see if changes have been made.

View, modify or delete data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to data processing or to object to the processing of your personal data by Winch Trading and you have the right to data portability.



This means that you can submit a request to send the personal data that we have available to you in a computer file to you or another organization mentioned by you. You can send a request for inspection, correction, deletion, data transfer of your personal data or request for cancellation of your consent or objection to the processing of your personal data to sales@winchtrading.nl.

In order to ensure that the request for access has been made by you, Winch Trading asks you to send a copy of your proof of identity with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. Winch Trading will respond to your request within a reasonable time, but no later than four weeks.

Winch Trading also wishes to point out that you have the opportunity to file a complaint with the national supervisory authority, <u>Autoriteit Persoonsgegevens</u>.
